Please submit the consolidated report after completing the above training programmes.

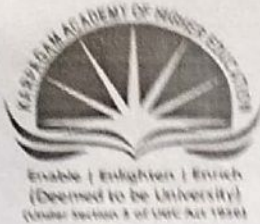
