## FEEDBACK PROCESS WITH RESPECT TO CURRICULUM

### INTRODUCTION/PREAMBLE

Feedback from the stake holders on curriculum provides the strengths, weaknesses, opportunities and threats relevant to quality assurance within the institute. In this regard, IQAC provides the necessary arrangements for feedback responses from students, teachers and other stakeholders on curriculum quality related institutional processes. The ultimate goal of stakeholder's feedback is to get useful insights for the enrichment of the curriculum.

### STAKEHOLDERS

1. Students
2. Alumni
3. Teachers
4. Employers

### TYPES OF FEEDBACK

- 1) Student feedback
- 2) Alumni feedback
- 3) Teacher Feedback
- 4) Employer feedback

#### 1. Students' Feedback:

Feedback from students on curriculum provides input on design of curriculum.

During the period 2015-16 to 2019-20 feedback is collected through questionnaire (as per the sample format Annexure I) from 10% of the total students from all departments. Questionnaire consists of 20 parameters exclusively on curriculum. The feedback was received based on a 5 point scale Very good (5), Good (4), Average (3), Poor (2), Very Poor (1). The performance score for each statement with weighted average was calculated and tabulated. If the weighted average is less than 3.5, remedial actions were necessary. If it exceeds 3.5, it is concluded that the curriculum is upto the expectations of the students.

Further a Student member is invited officially for the meeting of Board of Studies and he/she too participates in the deliberations.

#### 2) Alumni Feedback

The purpose of this feedback is to obtain the inputs from the alumni on the quality of the curriculum. This helps to assess the extent of attainment of the programme outcomes. Alumni feedbacks are collected (Annexure II) from all participating alumni of KAHE during Alumni

meet or through e-mail or when they visit the Departments. On an average around 250 members of alumni are forwarding the feedback.

The feedback was received based on a 5 point scale Very good (5), Good (4), Average (3), Poor (2), Very Poor (1). The performance score for each statement with weighted average was calculated and tabulated. If the weighted average is less than 3.5, remedial actions were necessary. If it exceeds 3.5, it is concluded that the curriculum is upto the expectations of the alumni.

### **3. Teachers' Feedback**

The purpose of the feedback is to obtain the teachers' input on the courses they are handling and the overall curriculum. This feedback will specifically target the curriculum design. The feedback from around 100 teachers are collected (Annexure III) once during an academic year. The suggestions made by the teachers were taken up for the discussion in the BOS.

### **4. Employers' Feedback**

The purpose of the feedback is to obtain the employers' input on the quality of the curriculum and to assess whether the expectations of recruiters were fulfilled. 50 employers were contacted getting feedback. The students' ability to handle the professional situations and knowledge acquired during their learning can also be assessed by the employers. The curriculum was sent to selected employers/industries and the feedback was obtained (Annexure IV). The feedback from employers/industries is collected electronically. The suggestions made by the employers/industries were taken up for the discussion in the BOS.

### **MODE OF FEEDBACK COLLECTION:**

Feedback collection is done either online or offline modes. Online mode includes submission of responses in the form of e-mails while offline submission involves the manual submission of feedback through printed questionnaire provided by Departments at requisite schedule.

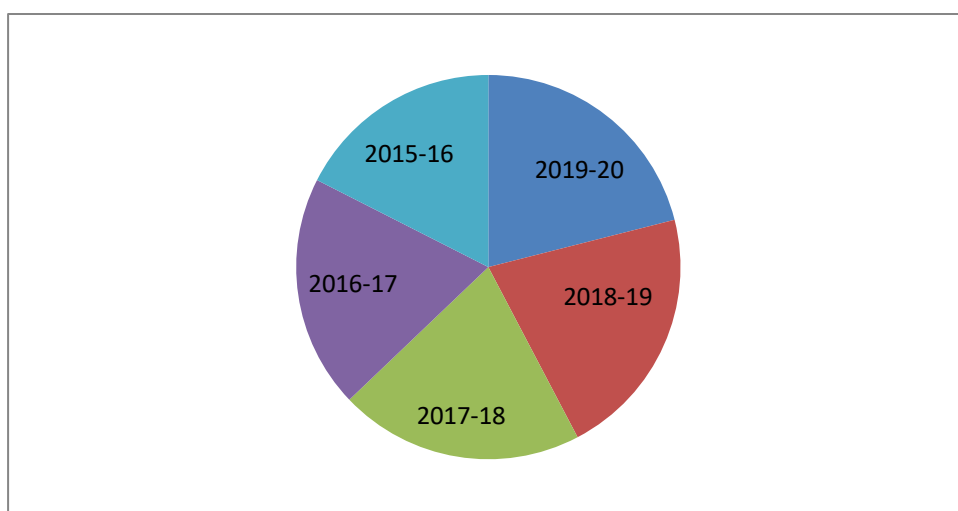

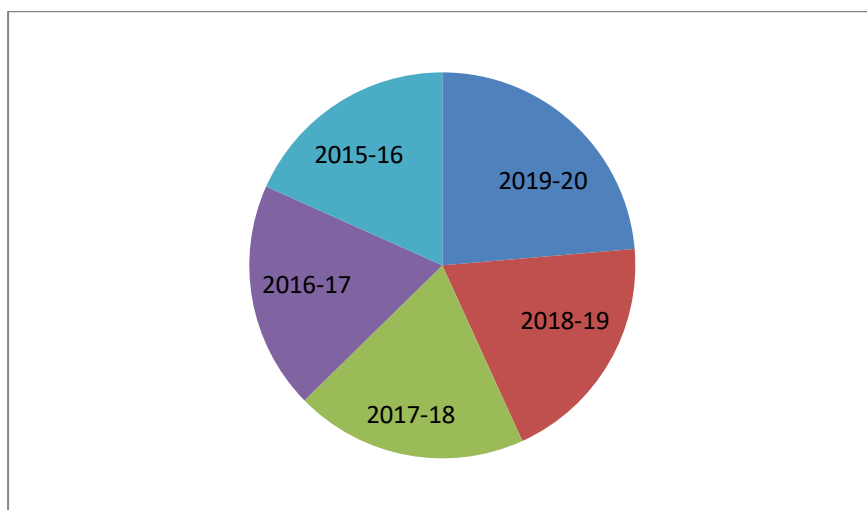


The number of feedback reports obtained from students for the past five years during the academic year 2015-2016 to 2019-2010 is shown in the below table



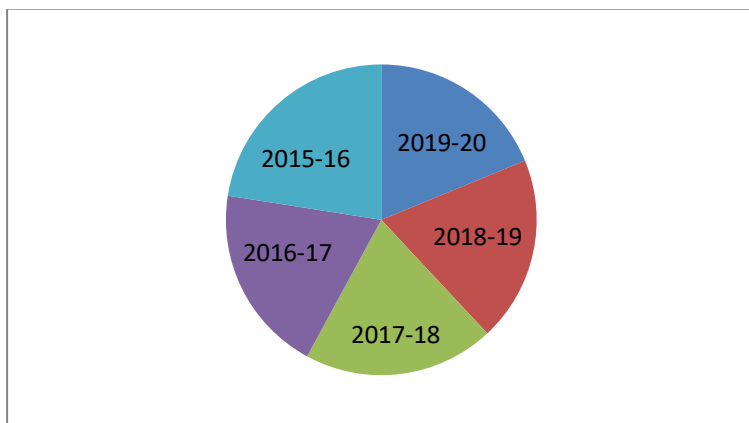
