POLICY FOR PROMOTION OF RESEARCH

In a globalized world, the Role of Research in an academic institution is imperative for its sustainability and development. The quest for knowledge is basic principle behind research. Needless to mention, the research bend of mind of the faculty has a direct bearing on the quality of teaching-learning, which in turn benefit the students, society and the nation. The promotion of research will help the country evolve as a knowledge reservoir in the international arena.

Karpagam Academy of Higher Education gives prime importance to research. It has 122 laboratories including the specialized research laboratories. All these laboratories are well equipped with latest equipments both for teaching and research.

Institution is keen to promote research to imbibe research culture among its faculty and students. Keeping this in mind, it has evolved a Policy for Promotion of Research.

1. Research Policy

- i. To provide conducive environment within which teaching faculty and students carry out their research with academic freedom in which individuals can pursue scholarly activities.
- ii. To ensure high quality and transparent research in the University.
- iii. To formulate a set of research initiatives to support significant research activities.
- iv. To ensure ethics in all research endeavours.

2. Promotion of Research

- i. Research Advisory Committee constituted, to advise various strategies to promote research.
- ii. To provide seed money for undertaking research with the objective of imbibing research culture among the new faculty members. Seed money of Rs.2 lakhs is provided for Research for Science programmes and Rs.50,000 for non-Science programmes.
- iii. To provide tuition fee concession to teaching faculty who register for part time Ph.D. programme and to Alumni for full time Ph.D. Programme.
- iv. To provide cash incentive to faculty members who publish in SCOPUS / Web of Science Journals.

- v. To meet registration fee and travel expenses of faculty to attend Research Seminars / Conferences.
- vi. To institute fellowship of Rs.10,000/- per month to 20 full time Research Scholars.
- vii. To grant sabbatical leave to faculty to pursue Post Doctoral Fellowship (PDF).
