Seed Money to faculty to promote Research in Karpagam Academy of Higher Education - Guidelines

1. The teaching faculty must have a Ph.D Degree in the discipline or related discipline concerned.
2. The faculty member should not be in receipt of any kind of financial assistance for Research Projects from any of the funding agencies / sources.
3. A maximum of Rs.1 lakh shall be provided as seed money.
4. The Research Proposal submitted by the faculty shall be evaluated by the Research Evaluation Committee and on their recommendation ,seed money shall be sanctioned.
5. The progress of the Research work shall be reviewed once in 3 months.The seed money shall be released in installments based on the satisfactory progress of the Research work.
6. If seed money is provided by the Institution , he / she must complete the project and submit the project report. Leaving the Institution in the middle of the project not permitted.In case of he / she leaves ,he / she has to refund the entire seed money sanctioned.
7. The details of Expenditure along with relevant vouchers / certificates to be submitted within a month of completion of Research project.
