- The part-time registered candidates should spend a minimum of 3 months residential program at the Department. The candidates can undergo the residential program in one phase or in three phases (i.e. one month per year) in consultation with the Research Supervisor. This is also applicable to part time NRI or Overseas Research Scholars.







Note: The total number of special papers in each discipline shall be ten. The candidate has to select one among the ten, in consultation with the guide.

The credit assigned to the M.Phil. or Ph.D. course work shall be 12 credits

The course work shall be treated as a prerequisite for M.Phil./Ph.D. preparation. A minimum of four credits shall be assigned to Research Methodology which could cover areas such as quantitative methods, computer applications, research ethics and review of published research in the relevant field, training, field work, etc. Other courses shall be advanced level courses preparing the students for M.Phil./ Ph.D. degree.

The Department where the scholar pursues his/her research shall prescribe the course(s) to him/her based on the recommendations of the Doctoral Committee. The candidates shall have to attend classes for 60 contact hours for each paper and a minimum of 80 percent attendance is required to become eligible for the examination. The scholar is required to write all the three courses within six months from the date of registration, but has to pass all the courses within a maximum of one and half years (three attempts). If the scholar does not complete course work within one and half years (three attempts) his/her registration will stand automatically cancelled.

The Part-Time Candidates shall have to attend classes for 60 contact hours for each paper which shall be conducted in the month of April/May and November/

December and a minimum of 80 percent attendance is required to become eligible for the examination. The scholar is required to write all the three courses within one year from the date of registration, but has to pass all the courses within a maximum of two years (three attempts). If the scholar does not complete course work within two years (three attempts) his/her registration will stand automatically cancelled.

A M.Phil./Ph.D. scholar has to obtain a minimum of 55% of marks or its equivalent grade in the UGC 7-point scale in the course work in order to be eligible to continue the programme and submit the dissertation/thesis.

Also Resolved to approve the revised pattern of question paper for course work for M.Phil and Ph.Dprogrammes.





GUIDELINES FOR AWARDING RESEARCH FELLOWSHIPS

- 1. Only Full time Ph.D. Research Scholars are entitled for fellowship.
- 2. If the Scholars are receiving any other kind of fellowship, they are not eligible to apply for the KAHE Research Fellowship.
- 3. The Scholars who have been selected for admission to Ph.D. (FT) programme have to take up a separate interview which shall be conducted immediately after first DCM.
- 4. The fellowship shall be awarded initially for two years and continuation of fellowship for third year is subject to approval by the Expert Committee constituted to review the research work of the Scholar.
- 5. The Institution has every right to decide the quantum of fellowship based on the performance of the Scholar in the beginning and in subsequent years.
- 6. In case of discontinuation of Ph.D.programme in the middle, the scholar has to refund the fellowship amount received.
- The Scholars are entitled for fellowship only for minimum period prescribed for the Ph.D. programme.
- 8. The Scholar has to submit monthly claim along with the report in the prescribed format through the Research Guide.
- 9. The Scholar has to acknowledge the receipt of fellowship in publications.
- 10.The number of allocation of fellowship to each Department / transfer of fellowship from one Department to another are at the discretion of the Deemed University Authorities.
- 11. The selected Scholar has to execute a Bond to avail the fellowship.
- 12. The Scholar can avail leave for a maximum of 12 days only in a year.






