KAHE has a well-defined Policy on Consultancy. The main features of Consultancy Policy are given below:

Role of the Institution

- To create a Directory of Consultancy Potential of the faculty of the Institution with the details of facilities available.
- To bring out brochures / leaflets specifying the ongoing Consultancy Services of the Institution.
- To co-ordinate R&D projects between the Institution and Industries in the area of product / process development and technology transfer.
- To assist signing of MoU and development of IPR / Patents based on products and processes developed by the faculty.
- To offer services of testing / material characterization and Certification.

RULES OF CONSULTANCY

- 1. A request for Consultancy Services shall be received by the Consultancy Cell or directly received by a faculty member. If it is received by individual faculty, it shall be forwarded to the Cell for its consideration.
- 2. Consultancy works/projects shall be undertaken only upon the approval of the Institution based on the recommendations of the Consultancy Cell.
- 3. All proposed consultancies involving the use of the Departmental equipment/ facilities shall have the approval of the Institution.
- 4. MoU with Industries, governmental and non-governmental agencies can be entered by the consultants/faculty members upon prior approval by the Institution on the recommendations of the Consultancy Cell and the authorized signatory for all MoUs shall be Registrar, Karpagam Academy of Higher Education.
- 5. The sharing of Consultancy Charges received by the Registrar shall be apportioned as follows:
 - a) Incase consultancy offered to external agencies with their facilities
