10. This collaborative agreement shall remain in force for unlimited duration until terminated by three months prior written notice given to on institute by the other institute.

V. FORCE DE MAJEURE

In the event premises of either party are rendered unsuitable for the conduct of activities or events by reason of Force Majeure, JSSINYS and KAHE may terminate this agreement by written notice and mutual consent following such casualty and JSSINYS, and, KAHE shall not be responsible for any damages sustained by either but either party shall be entitled to a prorate return on any sum paid or any other acceptable arrangement mutually agreed to by the parties. Force majeure shall mean fire, earthquake, flood, act of God, strikes or other labor disturbances, riots or civil commotion, litigation, terrorism, war or other acts of any foreign nation, power of Government or Government agency or authority, or any other cause like or unlike any cause abovementioned which is beyond the control or authority of JSSINYS and KAHE.
