- To utilize the faculty and facility resources of Karpagam Academy of Higher Education to the Prakash Gears industry for development.


Rules and Responsibilities of the Collaborative Agreement signing company

- In witness whereof the parties have set their hands here to on the day and the year first herein above writing under their seal of office.






