# **COLLABORATIVE AGREEMENT**

### Preamble

# Through this Collaborative Agreement, both the parties agree to the following:

- 1. To share the knowledge by conducting joint seminars, conferences and workshops in select subjects either at Centre for Bioscience and Nanoscience Research Coimbatore or at Karpagam Academy of Higher Education, Coimbatore by mutual consent.
- To allow undergraduate, post graduate, and research students and faculty of both the institutions to carry out, summer internships, research projects as per the requirements and approved plan of work.
- To make available and use of the existing instrumental facilities in the laboratories for the skill updation of students / faculty and for doing approved project work on payment of nominal charges fixed by mutual consent.
- 4. To invite resource persons on either side.
- Benefits such as improved technology, materials, process, design and techniques, accruing or arising from the collaborative effort may be used by either or both the parties with due recognition of each parties contribution only on agreement by both the parties.
- Results and findings from the collaborative research project may be used by either or both parties with due recognition of each parties contribution only after agreement by both the parties.
- Research publications by either party will give due and proper credit to other parties
  contribution, but the party publishing them will be entirely responsible for correctness of
  data and information published, conclusions and interpretations reported.

# Status of Collaborative Agreement

To discharge the responsibilities of each party, and/or when specific obligations or financial commitments appear necessary to the parties, the parties by mutual consent shall enter directly, into specific agreement(s) defining in detail the respective obligations and commitments of each party, and in particular the programme of work and the financial conditions of its expression.

## Validity

The Collaborative Agreement will be for an initial period of THREE years from the date of signing. The parties shall meet three months before completion of three years to decide a possible renewal of this Collaborative Agreement. The parties shall then sign a specific addendum.

## Amendment

This Collaborative Agreement may be amended upon the mutual consent of both the parties; but such amendment shall have no impact on any specific agreement then in force.

#### Termination

Any party upon providing a written notice of three months may terminate this Collaborative Agreement or in the event of force majeure prohibiting its continuity.

The expiry or termination of this Collaborative Agreement shall have no impact on any other specific agreement in force, which shall continue upto its normal expiry.

#### Arbitration

This Collaborative Agreement shall be subject to the jurisdiction of Coimbatore only. The parties in the dispute will share equally the cost of arbitration as intimated by the arbitrator.

## Confidentiality

All parties acknowledge the confidentiality of the information, which may be transferred between the parties from time to time as being essential to this Collaborative Agreement and agree not to disclose the same to any third party. However, each party shall be free to disclose such information, as is part of the public domain at the time of disclosure, or required to be disclosed by official authorities in accordance with the applicable law.
