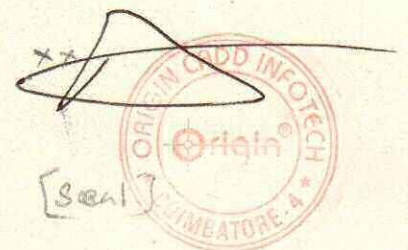

- To utilize the faculty and facility resources of Karpagam Academy of Higher Education to the Origin CADD Infotech industry for development.

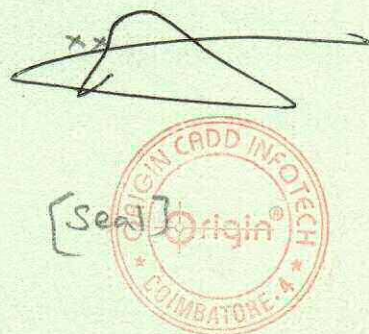
### Rules and Responsibilities of the Collaborative Agreement signing company
