

Rules and Responsibilities of the Collaborative Agreement signing company


- The Zenith Medical Equipments company shall permit the faculties designated inside their campus for interaction and development of the project.

- This agreement will be effective from 27.11.2019 for three years, the areas of co-operation can be extended through mutual consent.


Termination




