
- Senior officials from – Bothichittan Aqua farm will share their knowledge and experience by way of focussed special lectures, participating in seminars and other academic activities of KAHE.

- This agreement will be effective from February 2020 for two years; the areas of co-operation can be extended through mutual consent.


TERMINATION

- In witness whereof the parties have set their hands here to on the day and the year first herein above writing under their seal of office.


