6.2 Special Lecture on Enhancing Quality Education was conducted on 29.01.2020

Think-Equip-Reflect - Dr. Gopal Reddy, Member UGC

Think, Equip and Reflect on the quality initiatives of NAAC, Quality Mandate of UGC and New Education Policy 2019 exhorted Dr. Gopal Reddy, Member, UGC in his keynote address delivered in a function on Enhancing Quality of Higher Education organized by Karpagam Academy of Higher Education. The New education Policy 2019 goes extra mile in enhancing the quality of Higher education he added.
