6.3 Special Lecture on “ICSSR Schemes/Programs including Projects and Fellowships on 03.01.2020

The Internal Quality Assurance Cell (IQAC) has organized a Special Lecture on “ICSSR Schemes/Programs including Projects and Fellowships” for the benefit of the Faculty members of English, Commerce and Management departments on 03-01-2020 at 12 noon at Bharathi Hall. Fifty Faculty Members have attended the programme. Mrs. Revathy Vishwanath, Deputy Director, Indian Council for Social Science and Research (ICSSR), New Delhi was the Resource Person.

The Resource Person started her presentation with an emphasis on the responsibilities of the Faculty Members in addition to the Teaching Learning and Evaluation related activities. The Faculty Members are burdened with activities such as organising conferences, publications, extension activities, placement etc., The need for documenting the activities on regular basis is another difficulty faced by them.

Documentary evidence is the major and mandatory requirement for any assessment or accreditation process. No institution can get away with that and the responsibility ultimately lies on the Faculty Members only.

The IQAC of any Higher Education Institution is expected to act as the nodal point for collection of data and submission to Regulatory and Assessment Agencies time to time. The resource person stressed the need for supporting IQAC by providing reliable and accurate data in time to facilitate timely submission as and when called for by the various agencies.

She outlined the Revised Assessment Framework by NAAC and highlighted the salient features of various metrics. She also emphasised the need for timely submission of Annual Quality Assurance Report to NAAC by IQAC.

The programme was very much useful to the Faculty Members to realise the importance of various requirements in addition to the Teaching Learning and evaluation Process and their responsibility to rise to the occasion and support the institution in the journey of excellence in Quality.
