

Dear Sir / Madam,

Kindly recall my earlier letters of even number dated the 9th January, 2009 and the 13th July, 2009 respectively (copies uploaded on our website www.sakshat.ac.in) regarding the National Mission on Education through ICT (NMEICT), inviting participation of your institution and experts in the mammoth exercise of e-content generation, teacher empowerment and adopting e-learning as an effective means of teaching-learning activities. While some project proposals from the Universities and Institutions have started trickling in, the need is to accelerate this process and convert this into a movement for utilising the ICT tools to enhance the quality of instruction and reach of the educational delivery system to the unreached. I once again urge you kindly to proactively participate in the Mission and put creativity of your organisation to the best service of the Nation by utilising the resources (Rs. 900 crore) made available in the current year's budget.

- 2. As you are aware, providing connectivity to the Colleges, Institutions and Universities is a key component of the NMEICT, so that the high quality e-content could be reached to the teachers and students of these educational organisations. The connectivity under NMEICT would seamlessly integrate with the National Knowledge Network (NKN). You would be glad to know that the work of providing connectivity to these organisations has already been initiated by Bharat Sanchar Nigam Limited (BSNL), which has become a partner in this Mission by investing its resources.
- Universities in the Country has been envisaged under NMEICT at 25% cost to the Universities to begin with the Colleges and Institutes, BSNL officials will be providing 10 to begin with the Colleges and Institutes, BSNL officials will be providing 10 connections of 512 Kbps VPN over Broadband for unlimited use, with internet connectivity, to each of the Colleges / Institutions recognised under section 12-B of the University Grants-Commission (UGC) Act. These Colleges will have to bear 25% of the cost of this connectivity by paying their contribution directly to BSNL. The total financial burden on each College / Institution on account of this level of connectivity would not exceed Rs. 15000/- in the current financial year. Rest 75% cost would be borne by NMEICT by making direct centralised payment to BSNL. As an Institution / College starts using more and more of bandwidth, the number of connections to those active users would gradually be enhanced to upto 20 connections per institution. With a view to encouraging BSNL to bring, at its cost, optical fibre to as many Colleges / Institutions as possible, it would be desirable if the Colleges / Institutions consider providing some



space for setting up a mobile tower in their campuses. For participating in this scheme, the Colleges / Institutions may expect / require your concurrence.

4. I shall be grateful, if you could kindly Issue suitable instructions to the section 12-B recognised Colleges / Institutions of your University. I am also sending a copy of this letter to the Principal Secretary / Secretary of Higher Education of your State and also to all the Principals / Directors of UGC section 12-B recognised Colleges / Institutions. Let me add that the Mission covers all the educational institutions in the Higher Education domain, whether in public or private sector, and they would also be covered once their list is authenticated by State Govts. / Universities, for which a separate letter follows with a compiled list of such institutions.

BRIEF FOR VICE CHANCELLORS MEETING ON NMEICT AT CHENNAI ON 23RD DECEMBER, 2011

BSNL was awarded the prestigious project National Mission for Education through ICT (NMEICT). Under this project, BSNL is mandated with the following tasks, the status of which is briefed against each.

4	Internet bandwidth on demand (as approved by Ministry of HRD from time to time)	10 GB international bandwidth for international bandwidth

MHRD has further extended the scope of connectivity to colleges from 18,500 to 32,000 colleges.

The target for the connectivity is March 2012. MHRD emphasized that in absence of LAN availability in the universities, utilization of 1 Gbps bandwidth by Universities will be limited. Therefore, all efforts are made by BSNL to get LAN commissioned in the consented universities at an early date. It is also informed that only 25% of Cost of LAN shall be borne by Universities and the balance 75% shall be borne by MHRD.

To speed up the work of college connectivity and commissioning of LAN in various universities, it is proposed by MHRD that BSNL should conduct Zonal Meetings with Vice-Chancellors of various universities to expedite the progress on college connectivity and Local Area Network.

In view of the above, a meeting with Vice-Chancellors of the NMEICT Universities in South Zone is proposed to be at Chennai.

Kindly refer to letter under reference where in it was intimated that now, the universities work under NMEICT is to be executed. Following points may be noted in this respect:

- 1. BNW Circle has already uploaded detailed list of universities on the intranet. First list of 127 universities mapped to the NKN node has been received from NIC. These universities are to be connected to NKN node indicated. Concerned (SSAs) shall provide the connectivity to nearest exchange and then the link is to be made through to NKN node indicated. The work for these 127 universities needs to be taken up in the first phase immediately.
- 2. As far as billing of this OFC work is concerned, following are the broad guidelines:
 - For a transmission link up to 150 km, a flat rate of Rs 2 Cr/University has been accepted by MHRD. This is a one-time charge to be collected for 10 years. BSNL, being a stakeholder would offer a 10% discount on this amount and of the balance amount, MHRD would bear 75% cost & the university would bear 25% cost. This is explained below:

For the Ministry's share, STP shall raise the bill and send it to BNW circle
who will compile the total amount. For the University's share, individual
circles should raise the bill. Demand raised along with payment details shall
be sent by the respective circle to STP.

- 3. As per the understanding with MHRD, free ROW would be given to BSNI for OF works under this project and they would have written to individua state governments for this.
- 4. Respective circles shall coordinate with the concern regions to facilitate in extending the universities to the nearest NKN Node (Required bandwidth is 1GE). Requirement of transmission equipment if any for the above purpose may be projected to STP for further action at this end.
- 5. Southern Telecom Project is designated as the nodal circle for overseeing this job of providing OF connectivity to Universities. Nodal Officers from STP are as follows:
